Part of the Purchase Price will be paid immediately with this Agreement as a Deposit to guarantee that Seller will hold the Puppy for delivery to the Buyer on the below specified Delivery Date.

There are no refunds on Deposits, unless otherwise agreed here in writing. Failure of the Buyer to complete this purchase would subject Seller to lost opportunities to sell the Puppy to some other Buyer and retention of the Deposit is meant to compensate Seller for his possible loss. This deposit signifies the intent on the part of the Buyer to follow through with the Purchase of this Puppy.

The Seller reserves the right to void this transaction and refund the Deposit if we learn of any reason why Buyer might not be suitable for the puppy –( i.e. Buyer is found to be an animal abuser, violent person, representative of a Pet Store, representative of a pharmaceutical research laboratory etc.) .

**PREFERRED DEPOSIT PAYMENT METHOD IS PAYPAL OR CASH**

**HEALTH GUARANTEE**

**The warranty period is one year, from date of purchase. This warranty covers against fatal and life altering congenital diseases. This includes severe hip dysplasia which hampers the dog's movement and kidney heart**

**pancreas, spine and liver problems of a severe, life threatening or altering nature. If the dog dies within the warranty period, the buyer must pay to have the animal autopsied to determine the reason of the death. If the reason is found to be congenital, the seller will replace the puppy by other with similar characteristics but will not refund money. There is no cash refund of any kind in full or partial. The replacement puppy will be of equal value.**

**The animal must exhibit the congenital defect under its warranty period and the seller must be notified of the problem within two business days by the licensed veterinarian determination and have two reports from two unassociated veterinarians stating the same problem. A puppy with a defect must be returned or euthanized with the prior permission of the seller to qualify for a replacement puppy.**

**A returned puppy must be returned to the seller in good condition, other than the specified problem. No replacement puppy will be given if the original puppy has been neglected or abused.**

**The buyer is responsible for transportation costs to the seller for original puppy. CARE BULLDOG will be responsible for transportation costs to the buyer for replacement puppy.**

**This guarantee applies to the original buyer only and is not transferable to anybody else other than the buyer signed on the bottom of this page.**

**This guarantee does not cover what is considered normal in the bulldog breeds, Cherry Eyes, Entropies, Loose Hips, Skin Allergies, Elongated soft Palate, and Collapsed Nostrils, any kind of parasites, bacterias, or viruses and sicknesses caused by them will not be covered under this warranty.**

**These are also certain disorders that may be caused by environmental factors, for example: Allergies, Dysfunction, Demode tic, mange and other autoimmune disorders that are not covered by this guarantee.**

**The seller will not be responsible for any reaction to future vaccination.**

**The seller will not be responsible foe any medical expenses incurred associate with any health problem.**

**There is no guarantee or warranty that the buyer will be able to show or breed the dog regardless of show or breeding potential exhibited as a puppy.**

**This guarantee does not cover any physical problems which is or could be the result of injury.**

**This guarantee does not cover the presence of deafness or any kind of hearing problems as this may be the result of many other factors different from genetics such as antibiotic treatments, extremely strong noises, etc.**

**GENERAL**

Buyer agrees to keep their puppy at home and away from other dogs, public places, parks and will use care in allowing others from outside their home to pet or touch the puppy. This is to protect the puppy from exposure to parvovirus and other infectious illnesses. New owners will not enroll the puppy in obedience training classes until all immunizations are completed – usually at 18-20 weeks of age, according to the veterinarian’s schedule

I also accept the terms and conditions of the guarantee for congenital diseases printed in this document and I waive and relinquish any all other rights that I might otherwise have in the event of such occurrence.
